1. All works must have been completed within the last year (since last year's art show.)
2. Students must be in grades 7-12. This is not limited to students enrolled in an art class. Teachers please post where all students can see. Art is divided into 3 Divisions: 7 & 8, 9 & 10, 11 & 12.
3. All artwork may be dropped off during the following times: Monday, Tuesday, Wednesday & Friday 8am-4pm, Thursday 8am - 7pm starting February 22nd thru March 5th.

4. Categories
 - Drawing: pencil, charcoal, pen & ink, scratchboard
 - Color Works: oil, acrylic, watercolor, color pencil, pastel
 - 3D: weaving, sculpture, copper work, pottery, etc...
 - Graphics: print making, computer generated, collage, poster/letter making
 - Mixed Media any combination of mediums
5. Please attach a label (enclosed) to the back of each work. Include the category and specific medium(s) used.
6. All students may enter up to 3 works per category.
7. All entries must remain on display through April 2nd, 2011. Entries may be picked up beginning Tuesday April 5th, 2011, between the hours of 8 am - 4pm Tuesday, Wednesday & Friday, 8am - 7pm Thursday. All art pieces need to be picked up by April 15th, 2011. If you need different hours please call.
8. Entries will be judged and ribbons will be awarded for First, Second and Third Place in each category per division. Peoples Choice in each 3 Divisions: 7 & 8, 9 & 10, 11 & 12 will receive prize money 1st \$30, 2nd \$20, 3rd \$15. The People's Choice awards are voted on by the Center's Visitors and will be announced at the close of the show. Awards will be announced through local media and sent to the Art Instructors.
9. Each work must be original and completed entirely by the student. Commercial kits are not allowed.
10. Any work intended for hanging must have a sturdy hanger. Frames are optional. Unframed works will be accepted, but should be matted or mounted (tag board or heavy construction paper is fine.) Shrink-wrap is optional (however recommended to protect your artwork). Your works will not be judged on mats or frames; however, each work should be presented neatly.
11. A Judge will be chosen from area Artists/Professionals and all decisions are final. Judging will be done within the first week, if possible.
12. Please return the self-addressed reply card with your response by Friday, February 18th, 2011.
